iCHEMS is web-based, integrated management system designed to address the safety and surveillance needs of chemical & biological regulated environments. iCHEMS tracks the processes from ordering of chemicals at stores to usage of chemicals at the laboratories. iCHEMS provides alerts to enhance user productivity by highlighting the expiry dates of chemicals, licenses, SDS, etc. A powerful search engine is included to synchronize across HS Codes, CAS Numbers so as to allow rapid retrieval of information. In addition, iCHEMS offers a real-time inventory system that is able to interface with legacy systems like SAP, etc.


